

Visa requirements TURKEY

The Electronic Visa (e-Visa) Application System allows visitors travelling to Türkiye to easily obtain their e-Visas online (www.evisa.gov.tr), in approximately three minutes.

It is possible to obtain e-Visa 7/24 at everywhere with internet connection. The applicants can obtain their visa after they fill in the necessary information concerning their identity, passport and travel dates and pay visa fee online.



Please note that e-visa is only valid when the purpose of travel is tourism or commerce. Your travel document/passport must be valid for at least 6 months as from the date of your arrival in Türkiye.

Countries Visa not required

Turkey portrays a welcoming approach towards the tourists and is a visa-free regime for nationals of many countries. Those who are not Visa-Exempts can apply for Turkey e-Visa online application by the easy and swift process. Nationals of these countries can visit and stay in Turkey for 90 days every six months.

The online application applies to more than 95 countries all over the world. However, almost 60 countries need to fulfill the extra conditions to get an online visa. The conditions are:

The applicant has to show proof of residence and means of financial support (at least 50 USD per day) while staying in Turkey

A valid visa or residence permit from at least one of the countries of Schengen area countries, Ireland, the United Kingdom, or the United States is required. E-visa of these countries is not accepted.

Algerian citizens must be under 18 or over 35 to apply for an e-Visa of Turkey. Or else, they must apply from the embassy.

In the scenario of arriving at the Istanbul Ataturk Airport, the citizens of Zambia, and the Philippines are required to apply for a visa from the embassy. The E-Visa will not be accepted.

Documents Required for Turkey Visa:

1. Passport - Your passport should be valid for at least 180 months after your date of arrival and have 2 blank pages.
2. Passport details: number, place of issue, date of issue and expiration date
3. Certain nationalities require a supporting document such as a visa or residence permit from the Schengen, US, UK or Ireland. To view which nationalities, please visit our Turkey visa application and enter your nationality.
4. Email address
5. Credit or debit card

Fees for Turkey e-Visa:

Government e-Visa Fees:

The government e visa fee is charged by the policy of the Government of Turkey.

The cost ranges depending on your nationality from USD 78.50 to USD 61.50.

Service e-Visa fees:

The service e visa fee is charged for processing your visa and ensuring that you get your eVisa as quickly as possible. there is a service fee as:

Normal Processing within 1 - 2 Days: USD 39.00

Rush Processing within 6 - 12 Hours: USD 50.00

Super Rush Processing within 1 - 6 Hours: USD 70.00
