

Visa requirements for Uzbekistan

According to the legislation of the Republic of Uzbekistan foreign citizens and stateless persons can enter Uzbekistan or travel through its territory for transit on the basis of ENTRANCE VISAS only.



Foreign citizens and stateless persons can get VISAS at the diplomatic representations and consular missions of the Republic of Uzbekistan abroad on the basis of the visa support (confirmation of the Ministry of Foreign Affairs of the Republic of Uzbekistan).

Visa support

Visa support is issued on the basis of application of the inviting organization, company and persons who are permanently or temporarily residing in Uzbekistan and submitted to the Ministry of Foreign Affairs of the Republic of Uzbekistan.

Requirements for obtaining a Visa / Visa Support from your Tour Operator

The tourist visa for Uzbekistan can be applied for through Hodophile Experience - 50 € processing fee

In cases where the visa is intended to be obtained at the Tashkent airport - copies of the air ticket or reservation

In accordance with the legislation of the Republic of Uzbekistan, the following consular fees are established for the processing and issuance of visas:

a) For single-entry visas:

Up to 7 days - 40U\$	Up to 3 months - 80U\$
Up to 15 days - 50U\$	Up to 6 months - 120U\$
Up to 30 days - 60U\$	Up to 1 year - 160U\$

Note: The tariff rate increases by \$10 for each additional number of entries

electronic visa: evisa.mfa.uz

For a single-entry electronic visa - 20U\$

Written applications from legal entities and individuals submitted to the Ministry of Foreign Affairs of the Republic of Uzbekistan in accordance with the established procedure are considered within 4 working days
